SAFETY RECALL NOTICE

21 DEGREE & 30 DEGREE 18V FUSION CORDLESS FRAMING NAILERS

In certain circumstances, the dual action engagement system on the nailers can malfunction and involuntarily discharge a nail by pulling the trigger alone, without depressing the nosepiece contact element, posing a hazard to users. In an effort to eliminate this hazard, SENCO is conducting a voluntary product safety recall.

Only the following SENCO 18V Fusion Cordless Framing Nailers are affected:

Question: What is this recall?

ANSWER: This recall applies only to two specific SENCO framing nailer models manufactured during the time outlined in the official recall notice: F-35XP 30-degree paper tape Framing Nailer and F-35FRHXP 21-degree full round head Framing Nailer.

Question: Are these tools dangerous to use?

ANSWER: There have been no reports of malfunctions or injuries associated with these tools. However, under rare and specific conditions, the tool may unintentionally discharge a nail with just a trigger pull. This is why we are taking proactive safety measures.

Question: Can I continue to use the tool?

ANSWER: SENCO prioritizes user safety above all else. Please follow the instructions provided in the recall notice and discontinue use until the tool has been inspected and modified as needed.

Ouestion: What should I do with the tool?

ANSWER: Please provide your shipping address. We will send you a prepaid return label / acct number so you can send the tool back to SENCO. Once received, we will perform a modification to address the recall issue and return the tool to you.
